DECLARATION & INDEMNITY

I/We hereby make an application to participate in the **RALLY OF VALLEY 2023** and certify that the particulars of the participants and vehicle, as well as the documents submitted are correct and authentic.

I/We have read the Supplementary Regulations issued by AUTOZ 365 MOTORSPORTS for the **RALLY OF VALLEY 2023** and agree to be bound by them and the International Sporting Code of the FIA, FIM, the General Prescriptions, Sporting, Technical and Championship Regulations of FMSCI; as well as this undertaking.

In consideration of the acceptance of this entry, I agree to save harmless and keep indemnified the Government, the FMSCI, the Organizers, AUTOZ 365 MOTORSPORTS the FIA and their officials, the Sponsors, agents, representatives, employees and all persons assisting them in this event and all owners and tenants of private property traversed by this event, from and against all actions, claims, cost, expenses and demands in respect of death, disability or injury to myself or any other person or persons or loss or damage to any property including the car concerned in this event, if any or otherwise howsoever and notwithstanding that the same may have been contributed or occasioned by the negligence of the organizer and their official, agents, representatives, employees and all persons assisting them in this event or for that matter any fellow competitor. The indemnity shall be binding on my heirs, executors and legal representatives.

I also indemnify AUTOZ 365 MOTORSPORTS against any defects in the venue, hidden or exposed, variations to the competition track marked/laid out/ indicated by them or any decisions, under pressure of time/events, made by them during the event. I acknowledge and agree that if required, the organisers may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by them and agree to meet all costs and expenses associated with such action. I understand and accept that it is compulsory for me to have a medical insurance in some form and I accept responsibility for the cost of medical expenses that may exceed the cover provided by my insurance. The indemnity shall be binding on my heirs, executors and legal representatives.

I/We declare that the details given in the entry form are true and correct. I declare and reaffirm that all the documents submitted by me are true and genuine. I declare that the drivers possess the standard competence necessary for an event of this type to which this entry relates, also that the vehicle entered is suitable and rally worthy for the event. I agree and undertake to abide by the rules and regulations framed for this event including the conditions precedent set out herein and all other rules and regulations, which may hereinafter be framed.

I/We agree and undertake not to agitate, litigate or seek the decision of a Court of Law on any matter or question concerning or relating to the Rally commencing from the submission of the entry up to the conclusion of the event and the declaration or distribution of prizes. I also renounce and relinquish my/our right if any, to have recourse to any arbitrator or tribunal not provided for in the International rules of the FIA and/or regulations of the FIA and/or FMSCI.

I undertake that any advertisement pertaining to my participation, performance and placing in the event shall correctly state the correct and complete title of the event **RALLY OF VALLEY 2023**. Furthermore, I will make this condition clear to my sponsors. In addition, I undertake to not use my participation, performance and placing for any promotional and/or commercial purposes without the prior written permission of the organisers.

I acknowledge that AUTOZ 365 MOTORSPORTS enjoys the sole intellectual property rights of the event including the rights of use or distribution relative to all material, including, but without being limited thereto, logos, graphics and illustrations, images, film, footage and photographs, articles, editorial content, journalistic magazines, interviews and results. I shall refrain from using in any form copying, duplicating, extracting, digitising or disassembling onto any medium, altering, selling, republishing, transmitting, distributing on or offline or directly or indirectly exploiting for commercial purposes, all or part of the tangible & intangible Elements of the event.
